## PREFACE

The information contained in the following report was taken from the shift reports from the Governor Wallace detail. Each day a different agent was assigned to the task of compiling this information, therefore, it is not uniform. Inaccuracies in listing people on airplane manifests allowed that only the names of Governor Wallace and the supervisory agent remains correct throughout.

The activities of Mrs. Wallace are likewise not constant throughout this report, and in some instances her whereabouts can not be determined from shift reports. Some entries in this report concerning Mrs. Wallace are questionable, but she has been included because of events which she was known to have participated.

On several occasions, the event which Governor Wallace was attending was not noted in the shift reports and therefore does not appear in this report.

The activities of the Wallace children are not noted even after the events of May 15, 1972. In this regard, the activities of Mrs. Wallace after that date are noted only when they concern her trips to California, Texas, South Carolina, and to Walter Reed Hospital in Washington, D. C. Her movements in the greater Washington area (such as beauty shop appointments and shopping) have not been included. Those movements are available, but somewhat inaccurate in the available shift reports.

Air craft and automobile passengers traveling with Governor Wallace are not necessarily included in the shift reports. Only those names that were included, are listed in this report.

The Governor Wallace protective detail was activated on Monday, March 20, 1972, at the Governor's Mansion in Montgomery, Alabama.
