## BY TELEGRAPH.

**WASHINGTON, May 14.**  
The House passed the bill amending the charter of the Freedmen's Savings and Trust Company.

**NEW ORLEANS, May 13.**  
The Spanish Consul, Don Carlos Pie, Gen. Rader, the Chief of Police, and Detective Harris and Parsons, gave bonds to-day in \$20,000 each to appear for trial upon a charge of robbery, preferred by Capt. Rodriguez, the Grand Jury having found true bills against them.

The Board of Directors of the Cotton Exchange, in consideration of requests from other Exchanges, passed resolutions suggesting June 10th as the day for the assembling of the Cotton Exchange Convention, in Augusta, Georgia; also, that the number of delegates from each Exchange be increased to five.

**NEW YORK, May 14.**

**LITTLE ROCK, May 14.**

**NEW YORK, May 14.**  
At a conference of the Liberal Representatives of the State at which 30 delegates were present, was resolved to keep the organization intact, and a call was issued for a State Convention to which men of all parties who favor honesty and purity in the Government will be invited.

**CINCINNATI, O., May 13.**  
A. Cochran's distillery, and Williams & Green's Malt house at Tippecanoe, O., were burned yesterday. Loss \$90,000.

**MADRID, May 14.**  
The new ministers were sworn into office yesterday. The Governors of several provinces and a number of other high officials have resigned since the change.

**ROME, May 14.**  
The Pope replying to a visitor from America, animatedly and severely on the Government of Mexico and Guatemala, for permitting bitter persecutions of the Church in those countries. The Pope appeared fatigued and was unable to give audiences to all the delegations which waited upon him.

**WILMINGTON, May 14.**  
The Iron Steamship Hudson, 2,500 tons, for the Cronwell, New York and New Orleans line, was launched this morning from the shipyard of Pusey, Jones & Co., in the presence of 5,000 spectators. She is 300 feet long.
